ZixPort will provide custom branding and encrypted messaging functionality to Sierra's Web site.

"ZixCorp services make ongoing management and administration easier," said Sean Gallagher, director of information systems security for Sierra. "We're comfortable knowing that human error is out of the equation and that our PHI is being scanned and identified correctly. After reviewing our options, we realized that ZixCorp had the best technology and the best handle on HIPAA security requirements."

Sierra's subsidiaries currently offer a health maintenance organization, preferred provider organization, health and life indemnity insurance, behavioral healthcare services, and third-party administration for self-insured companies. Sierra's subsidiaries also include Southwest Medical Associates, Nevada's largest multi-specialty group and Health Plan of Nevada, Inc., the state's largest HMO.
