# Zix Corporation to Announce Q1 2004 Results on May 4, 2004

Company Also Announces Annual Meeting of Shareholders and Webcast on Thursday, May 6, 2004, at 10 a.m. ET (9:00 a.m. CT)

## **Stock Option Grant Announcement**
