Zix Corporation Selected by New York Bankers Service Corporation as an Endorsed Vendor

ZixMail is an easy-to-use desktop encryption solution and ZixPort provides custom branding and encrypted messaging capability to corporate Web sites.

"Bank security is a top priority for NYBA, and ZixCorp's encryption services prevent serious security breaches such as identity theft, and complement the security programs we offer our membership," said Michael P. Smith, president of NYBA. "Many factors made ZixCorp the right choice as an endorsed vendor, including its lexicon geared specifically to financial users and its roster of current clients, including the Office of the Comptroller of the Currency."

For more than a century, NYBA has provided advocacy and leadership for New York's financial services industry. The association represents 10 of the top 20 commercial banks in the nation, as well as regional and community banks.

"The support of NYBSCO, will add to our base of existing financial clients, and accelerates ZixCorp.'s growing presence in the financial community," said Rick Spurr, president and chief operating officer for ZixCorp.
