Managed TLS service enables financial services industry to extend secure communications with a single connection

Additionally, more than 30 states have existing legislation surrounding secure electronic communication. To aid the financial services community with a quick and easy email encryption solution, ZixCorp can deploy ZixConnect in just a few hours. This transparent service enables users to send and receive emails seamlessly while email retention policies remain enforced. ZixConnect is also ideal for existing ZixCorp Email Encryption Service clients who need to communicate with certain partners through TLS but would rather not setup and maintain the connection directly from their existing ZixVPM system.
