CapitaCommercial Trust Management Limited, as manager (the "**Manager**") of CapitaCommercial Trust ("**CCT**"), wishes to announce that S\$29,000,000 in aggregate principal amount of S\$225,000,000 2.7 per cent. convertible bonds due 2015 (the "**Convertible Bonds**") have been converted and cancelled. This is due to an exercise of conversion rights by the holders thereof.

Together with the current conversion, the total principal amount of **Convertible Bonds** converted and cancelled up to the date of this announcement is S\$96,250,000. Following the conversion and cancellation, the aggregate principal amount of **Convertible Bonds** remaining outstanding as of 26 June 2014 is S\$63,500,000.

Arising from the current conversion, 24,316,618 new **Units** in **CCT** have been issued at the conversion price of S\$1.1926 per **Unit**, and the total **Units** in issue is 2,934,542,512.
