

Register online


To register online you will need **your holder number**. You will also need **the postcode of your shareholding address** or **your country of residence** if you are located outside Australia.

You can find these details on a dividend statement.

For easy reference why not print this page and write your holder number and postcode into the space at the top of the next page.



From the home page, go to **Manage your shareholding** which is in the top right corner and pull down the **Log in to** box to select **My AMP shareholding**



To register online, click on the **Register** tab to select a User ID and password. You will need your **holder number** which starts with the letter I, x, n or L, followed by 10 numbers and **the postcode of your shareholding address** or **your country of residence** if you are located outside Australia.
