- 5. The Non-Refundable Deal Origination Fee is earned on the date of the Senior Facility Agreement but shall only become payable on the earlier of:
 - (a) the Utilisation Date;
 - (b) 1 February 2016; and
 - (c) the last day of the Availability Period.
- 6. The Non-Refundable Deal Origination Fee is payable by you to the Agent for the account of the Arrangers (to be divided proportionately to the Commitment of each Arranger or their affiliate (as applicable)) in sterling, in immediately available, freely transferable, cleared funds to the following account or any other account notified to you by the Agent for this purpose:

- 8. This letter shall supersede all prior understandings and proposals, whether written or oral, between the Arrangers, on the one hand, and the Payor (or any other member of the Group) on the other hand, relating to matters set forth herein and the transactions contemplated hereby.
- 9. This letter may be signed in any number of counterparts. This has the same effect as if the signature on the counterparts were on a single copy of this letter.
- 10. A person who is not a party to this letter may not rely on it and the terms of the Contracts (Rights of Third Parties) Act 1999 are excluded. Any amendments to this letter may be made without the consent of any third party.
- 11. This letter and all non-contractual obligations arising from or connected with it are governed by English law.
