**CLARIFICATION ANNOUNCEMENT RELATING TO PROPOSED DISPOSAL OF TOP
GLOBAL ENTERPRISES PTE LTD**

1. INTRODUCTION

- 1.1 Pursuant to the announcement on SGXNet (the “**Disposal Announcement**”) dated 12 March 2010, the Board of Directors of Top Global Limited (the “**Company**”) announced that the Company has, as vendor, on 12 March 2010, entered into a sale and purchase of shares agreement on 12 March 2010 (the “**SPA**”) with Cementmix Pte. Ltd., a company incorporated in Singapore, to dispose of the entire issued share capital of its wholly-owned subsidiary Top Global Enterprises Pte Ltd.

**2. CLARIFICATIONS ON RELATIVE FIGURES UNDER RULE 1006(C) OF THE RULES
OF CATALIST OF THE LISTING MANUAL OF THE SGX-ST**

- 2.1 The Company wishes to clarify the relative figure computed pursuant to Rule 1006(c) of the Rules of Catalist of the Listing Manual of the SGX-ST under Paragraph 6 of the Disposal Announcement, which should read as follows:
