ISSUE AND ALLOTMENT OF SHARES PURSUANT TO EXERCISE OF WARRANTS

The Board of Directors of Top Global Limited (the “Company”) wishes to announce that the issued share capital of the Company has increased from 11,239,523,858 ordinary shares to 11,241,657,748 ordinary shares by way of the allotment and issue of 2,133,890 new ordinary shares pursuant to the exercise of 2,133,890 Warrants (W29092015) at the exercise price of S\$0.005 for each new ordinary share on 14 January 2013.
