ISSUE AND ALLOTMENT OF SHARES PURSUANT TO EXERCISE OF WARRANTS

The Board of Directors of Top Global Limited (the “Company”) wishes to announce that the issued share capital of the Company has increased from 11,241,755,748 ordinary shares to 11,252,802,748 ordinary shares by way of the allotment and issue of 11,047,000 new ordinary shares pursuant to the exercise of 11,047,000 Warrants (W12062013) at the exercise price of S\$0.005 for each new ordinary share on 13 March 2013.
