VOCUS RENEWS SUPPLIER ARRANGEMENTS

Monday, 18 April 2016: Vocus Communications Limited ('Vocus', ASX: VOC) is pleased to announce that it has renewed supplier arrangements with key Australian suppliers of fixed and mobile access services.

New supplier arrangements with Telstra

Vocus subsidiary M2 Group Ltd ('M2') has entered into new supply arrangements with Telstra Corporation Limited ('Telstra').

The new arrangements, expiring 30 June 2019, replace the existing similar arrangements with Telstra, due to expire on 30 June 2016. The arrangements define the terms on which Telstra supplies various fixed voice and broadband services to key Vocus retail brands Commander, Dodo and iPrimus.

Geoff Horth, Vocus CEO, said of the new arrangements, *"We are pleased to build upon our long-standing relationship with Telstra Wholesale, ensuring a strong ongoing competitive market position for our key retail brands"*.

Extension of wholesale mobile agreements with Optus

Following a comprehensive and competitive tender process Vocus, through its subsidiaries, has also entered into a binding agreement with Optus Mobile Pty Ltd ('Optus') to extend the formal term of agreements with Optus for the supply of wholesale mobile voice and mobile broadband services.

The agreement extends existing arrangements from their expiry date of July 2016, until 30 June 2019. Wholesale Mobile Services are resupplied by Vocus predominantly to retail customers under the Commander, iPrimus and Dodo brands.

Geoff Horth, Vocus CEO, said of the new arrangements, *"We are pleased to have concluded this tender process and to be extending our long standing relationship with Optus. We look forward to delivering growth in our mobile portfolio on the back of this new partnership"*.
