(I) Acquisition of Wilmar International Limited Convertible Bonds due 2012 ("Wilmar Bonds") - Mr Teo Kim Yong has on 17th October 2008 acquired USD800,000 Wilmar Bonds as follows:

- (a) USD400,000 Wilmar Bonds at 64.25% for USD257,000
- (b) USD200,000 Wilmar Bonds at 65.25% for USD130,500
- (c) USD200,000 Wilmar Bonds at 66% for USD132,000

Note: The Wilmar Bonds may, at the option of the holder, be converted at any time on or after 27th January 2008 pursuant to the terms and conditions of the Wilmar Bonds. For more information on Wilmar Bonds, please refer to announcements dated 29th November 2007, 6th, 12th and 18th December 2007 released by the Company.
