

## Kayne Anderson Midstream/Energy Fund Provides Unaudited Balance Sheet Information and Announces its Net Asset Value and Asset Coverage Ratios at March 31, 2013

HOUSTON, TX – April 1, 2013 – Kayne Anderson Midstream/Energy Fund, Inc. (the “Fund”) (NYSE: KMF) today provided a summary unaudited statement of assets and liabilities and announced its net asset value and asset coverage ratios under the Investment Company Act of 1940 (the “1940 Act”) as of March 31, 2013.

As of March 31, 2013, the Fund’s net assets were \$743 million and its net asset value per share was \$33.87. As of March 31, 2013, the Fund’s asset coverage ratio under the 1940 Act with respect to senior securities representing indebtedness was 530% and the Fund’s asset coverage ratio under the 1940 Act with respect to total leverage (debt and preferred stock) was 394%.

The Fund had 21.94 million common shares outstanding as of March 31, 2013.

As of March 31, 2013, equity and debt investments were 89% and 11%, respectively, of the Fund's long-term investments of \$994 million. Long-term investments were comprised of Midstream Companies (44%), MLP and MLP Affiliate (39%), Other Energy (5%), Other (1%) and Debt (11%).
