

Kayne Anderson Midstream/Energy Fund Provides Unaudited Balance Sheet Information and Announces its Net Asset Value and Asset Coverage Ratios at May 31, 2013

HOUSTON, TX – June 4, 2013 – Kayne Anderson Midstream/Energy Fund, Inc. (the “Fund”) (NYSE: KMF) today provided a summary unaudited statement of assets and liabilities and announced its net asset value and asset coverage ratios under the Investment Company Act of 1940 (the “1940 Act”) as of May 31, 2013.

As of May 31, 2013, the Fund’s net assets were \$737 million and its net asset value per share was \$33.55. As of May 31, 2013, the Fund’s asset coverage ratio under the 1940 Act with respect to senior securities representing indebtedness was 433% and the Fund’s asset coverage ratio under the 1940 Act with respect to total leverage (debt and preferred stock) was 341%.

The Fund had 21.97 million common shares outstanding as of May 31, 2013.

As of May 31, 2013, equity and debt investments were 88% and 12%, respectively, of the Fund's long-term investments of \$1.1 billion. Long-term investments were comprised of Midstream Companies (45%), MLP and MLP Affiliate (38%), Other Energy (4%), Other (1%) and Debt (12%).

The Fund anticipates that the majority of its investments will consist of investments in Midstream MLPs and Midstream Companies.
