4	Any alterations made in this form must be initialed.
5	To be effective, the proxy form and any authority under which it is executed (or a certified copy of such authority) must be deposited at the principal place of business of the Company at 36th Floor, The Centrium, 60 Wyndham Street, Central Hong Kong (the "Office") no later than the time for holding the Meeting. Completion and return of the proxy form will not prevent shareholders entitled to vote from attending and voting in person at the Meeting.
