FURTHER SYNDICATIONS OF STAKE IN PROPERTIES IN THE UNITED STATES OF AMERICA

Global Logistic Properties Limited (the "Company") refers to the announcements dated 24 May 2016, 16 June 2016 and 12 July 2016 in relation to the further syndications of an aggregate interest of approximately 24.49% (the "Additional Syndications") in a portfolio of industrial assets in the United States of America (the "Portfolio") by its indirect wholly-owned subsidiary, New Western Holdings, LLC, for an aggregate cash consideration of US\$485 million, subject to post-closing adjustments.

The Company is pleased to announce that the Additional Syndications have been completed on 7 September 2016. The Company's interest in the Portfolio which was acquired from companies affiliated with Industrial Income Trust Inc., has been reduced to 9.85%. Following the completion of the Additional Syndications, the portfolio companies holding such assets (as set out in Appendix A) ceased to be associated companies of the Company.
