1. INTRODUCTION

Elliott International L.P. refers to:

- (a) the announcement dated 14 July 2017 ("**Joint Announcement**") in relation to the proposed acquisition by Nesta Investment Holdings Limited of all the issued ordinary shares ("**Shares**") in the capital of Global Logistic Properties Limited (the "**Company**") by way of a scheme of arrangement under Section 210 of the Companies Act (Cap. 50) of Singapore ("**Scheme**"), in accordance with the Singapore Code on Take-overs and Mergers ("**Code**"); and
- (b) the substantial shareholding notifications released on 14 July 2017 in relation to Elliott Capital Advisors, L.P., Braxton Associates, Inc., Elliott Asset Management LLC, Paul Elliott Singer, Elliott International L.P., Hambledon Inc., and Elliott International Capital Advisors Inc. (together, the "**Elliott Entities**") in relation to Shares held in the Company (the "**14 July Notification**").

The relationship between the various Elliott Entities are as set out in the 14 July Notification. All capitalised terms used and not defined herein shall have the same meanings as ascribed to them in the Joint Announcement, unless otherwise expressly stated or where the context otherwise requires.
