

Kayne Anderson Midstream/Energy Fund Provides Unaudited Balance Sheet Information and Announces its Net Asset Value and Asset Coverage Ratios at September 30, 2013

HOUSTON, TX – October 2, 2013 – Kayne Anderson Midstream/Energy Fund, Inc. (the “Fund”) (NYSE: KMF) today provided a summary unaudited statement of assets and liabilities and announced its net asset value and asset coverage ratios under the Investment Company Act of 1940 (the “1940 Act”) as of September 30, 2013.

As of September 30, 2013, the Fund’s net assets were \$769 million and its net asset value per share was \$34.94. As of September 30, 2013, the Fund’s asset coverage ratio under the 1940 Act with respect to senior securities representing indebtedness was 461% and the Fund’s asset coverage ratio under the 1940 Act with respect to total leverage (debt and preferred stock) was 360%.

The Fund had 22.01 million common shares outstanding as of September 30, 2013.

As of September 30, 2013, equity and debt investments were 88% and 12%, respectively, of the Fund's long-term investments of \$1.1 billion. Long-term investments were comprised of Midstream Companies (46%), MLP and MLP Affiliate (37%), Other Energy (4%), Other (1%) and Debt (12%).

The Fund's investment objective is to provide a high level of total return with an emphasis on making quarterly cash distributions to its stockholders by investing at least 80% of its total assets in securities of companies in the Midstream/Energy Sector, consisting of: (a) Midstream Master Limited Partnerships ("MLPs"), (b) Midstream Companies, (c) Other MLPs and (d) Other Energy Companies. The Fund anticipates that the majority of its investments will consist of investments in Midstream MLPs and Midstream Companies.
