

Kayne Anderson Midstream/Energy Fund Provides Unaudited Balance Sheet Information and Announces its Net Asset Value and Asset Coverage Ratios at April 30, 2014

HOUSTON, TX – May 2, 2014 – Kayne Anderson Midstream/Energy Fund, Inc. (the “Fund”) (NYSE: KMF) today provided a summary unaudited statement of assets and liabilities and announced its net asset value and asset coverage ratios under the Investment Company Act of 1940 (the “1940 Act”) as of April 30, 2014.

As of April 30, 2014, the Fund’s net assets were \$869 million and its net asset value per share was \$39.31. As of April 30, 2014, the Fund’s asset coverage ratio under the 1940 Act with respect to senior securities representing indebtedness was 515% and the Fund’s asset coverage ratio under the 1940 Act with respect to total leverage (debt and preferred stock) was 356%.

The Fund had 22,118,047 common shares outstanding as of April 30, 2014.

As of April 30, 2014, equity and debt investments were 90% and 10%, respectively, of the Fund's long-term investments of \$1.2 billion. Long-term investments were comprised of Midstream Company (43%), MLP and MLP Affiliate (38%), Other Energy (8%), Other (1%) and Debt (10%).

The Fund anticipates that the majority of its investments will consist of investments in Midstream MLPs and Midstream Companies.
