

## Kayne Anderson Midstream/Energy Fund Provides Unaudited Balance Sheet Information and Announces its Net Asset Value and Asset Coverage Ratios at July 31, 2014

HOUSTON, TX – August 4, 2014 – Kayne Anderson Midstream/Energy Fund, Inc. (the “Fund”) (NYSE: KMF) today provided a summary unaudited statement of assets and liabilities and announced its net asset value and asset coverage ratios under the Investment Company Act of 1940 (the “1940 Act”) as of July 31, 2014.

As of July 31, 2014, the Fund’s net assets were \$928 million and its net asset value per share was \$42.66. As of July 31, 2014, the Fund’s asset coverage ratio under the 1940 Act with respect to senior securities representing indebtedness was 451% and the Fund’s asset coverage ratio under the 1940 Act with respect to total leverage (debt and preferred stock) was 333%.

The Fund had 21,751,136 common shares outstanding as of July 31, 2014.

As of July 31, 2014, equity and debt investments were 92% and 8%, respectively, of the Fund's long-term investments of \$1.3 billion. Long-term investments were comprised of Midstream Company (41%), MLP and MLP Affiliate (39%), Other Energy (11%), Other (1%) and Debt (8%).
