

## Kayne Anderson Midstream/Energy Fund Provides Unaudited Balance Sheet Information and Announces its Net Asset Value and Asset Coverage Ratios at August 31, 2014

HOUSTON, TX – September 3, 2014 – Kayne Anderson Midstream/Energy Fund, Inc. (the “Fund”) (NYSE: KMF) today provided a summary unaudited statement of assets and liabilities and announced its net asset value and asset coverage ratios under the Investment Company Act of 1940 (the “1940 Act”) as of August 31, 2014.

As of August 31, 2014, the Fund’s net assets were \$1.0 billion and its net asset value per share was \$47.50. As of August 31, 2014, the Fund’s asset coverage ratio under the 1940 Act with respect to senior securities representing indebtedness was 472% and the Fund’s asset coverage ratio under the 1940 Act with respect to total leverage (debt and preferred stock) was 351%.

The Fund had 21,625,539 common shares outstanding as of August 31, 2014.

As of August 31, 2014, equity and debt investments were 93% and 7%, respectively, of the Fund's long-term investments of \$1.4 billion. Long-term investments were comprised of Midstream Company (41%), MLP and MLP Affiliate (40%), Other Energy (11%), Other (1%) and Debt (7%).
