Kayne Anderson Midstream/Energy Fund Provides Unaudited Balance Sheet Information and Announces its Net Asset Value and Asset Coverage Ratios at February 29, 2012

HOUSTON, TX – March 2, 2012 – Kayne Anderson Midstream/Energy Fund, Inc. (the "Fund") (NYSE: KMF) today provided a summary unaudited balance sheet and announced its net asset value and asset coverage ratios under the Investment Company Act of 1940 (the "1940 Act") as of February 29, 2012.

As of February 29, 2012, the Fund's net assets were \$635 million and its net asset value per share was \$29.17. As of February 29, 2012, the Fund's asset coverage ratio under the 1940 Act with respect to senior securities representing indebtedness was 456% and the Fund's asset coverage ratio under the 1940 Act with respect to total leverage (debt and preferred stock) was 385%.

As of February 29, 2012, equity and debt investments were 84% and 16%, respectively, of the Fund's long-term investments of \$856 million. Long-term investments were comprised of Midstream Companies (43%), MLP and MLP Affiliate (36%), Other Energy (4%), Other (1%) and Debt (16%).
