

## Kayne Anderson Midstream/Energy Fund Provides Unaudited Balance Sheet Information and Announces its Net Asset Value and Asset Coverage Ratios at December 31, 2013

HOUSTON, TX – January 3, 2014 – Kayne Anderson Midstream/Energy Fund, Inc. (the “Fund”) (NYSE: KMF) today provided a summary unaudited statement of assets and liabilities and announced its net asset value and asset coverage ratios under the Investment Company Act of 1940 (the “1940 Act”) as of December 31, 2013.

As of December 31, 2013, the Fund’s net assets were \$818 million and its net asset value per share was \$37.09. As of December 31, 2013, the Fund’s asset coverage ratio under the 1940 Act with respect to senior securities representing indebtedness was 432% and the Fund’s asset coverage ratio under the 1940 Act with respect to total leverage (debt and preferred stock) was 347%.

The Fund had 22,044,045 common shares outstanding as of December 31, 2013.

As of December 31, 2013, equity and debt investments were 89% and 11%, respectively, of the Fund's long-term investments of \$1.2 billion. Long-term investments were comprised of Midstream Companies (45%), MLP and MLP Affiliate (38%), Other Energy (5%), Other (1%) and Debt (11%).
