

Kayne Anderson Midstream/Energy Fund Provides Unaudited Balance Sheet Information and Announces its Net Asset Value and Asset Coverage Ratios at November 30, 2016

HOUSTON, TX – December 2, 2016 – Kayne Anderson Midstream/Energy Fund, Inc. (the “Fund”) (NYSE: KMF) today provided a summary unaudited statement of assets and liabilities and announced its net asset value and asset coverage ratios under the Investment Company Act of 1940 (the “1940 Act”) as of November 30, 2016.

As of November 30, 2016, the Fund’s net assets were \$384 million and its net asset value per share was \$17.41. As of November 30, 2016, the Fund’s asset coverage ratio under the 1940 Act with respect to senior securities representing indebtedness was 455% and the Fund’s asset coverage ratio under the 1940 Act with respect to total leverage (debt and preferred stock) was 351%.

The Fund had 22,034,170 common shares outstanding as of November 30, 2016.

As of November 30, 2016, equity and debt investments were 86% and 14%, respectively, of the Fund's long-term investments of \$534 million. Long-term investments were comprised of MLP and MLP Affiliate (42%), Midstream Company (41%), Other Energy (3%), and Debt (14%).

The Fund's investment objective is to provide a high level of total return with an emphasis on making quarterly cash distributions to its stockholders by investing at least 80% of its total assets in securities of companies in the Midstream/Energy Sector, consisting of: (a) Midstream Master Limited Partnerships ("MLPs"), (b) Midstream Companies, (c) Other MLPs and (d) Other Energy Companies. The Fund anticipates that the majority of its investments will consist of investments in Midstream MLPs and Midstream Companies.
