Venus Real Estate Investment Limited, an indirect subsidiary of the Company, had on 13 June 2018 submitted an application to remove its name from the Register of Companies under Section 309(1)(d) of the Companies Act 2001 of the Republic of Mauritius.

(d) Investment in an Associated Company

City Connected Communities Pte. Ltd. ("City Connected"), an indirect subsidiary of the Company, had on 14 June 2018 subscribed for 30 ordinary shares in Distrii Technology Singapore Pte. Ltd. ("Distrii Technology") at an aggregate sum of S\$2.5 million, being 30% of the shareholding interests in Distrii Technology.

City Connected had on 18 May 2018 entered into a Joint Venture Agreement with Distrii Technology, Distrii Singapore Pte. Ltd. ("Distrii Singapore") and Shanghai Distrii Technology Development Co., Ltd., the holding company of Distrii Singapore, for the establishment of Distrii Technology as a joint venture company. Distrii Technology's main business activities include software consultancy and development of other software and programming activities including smart building and smart office applications.
