Ltd. (“**FSMPL**”), incorporated in Singapore, has been struck off from the Register of Accounting and Corporate Regulatory Authority of Singapore pursuant to Section 344A of the Companies Act, Chapter 50.

FSMPL had been dormant since 1 April 2017.
