**2018 ANNUAL MEETING GUIDE**

**I. Annual Meeting Date**

The 2018 Annual Meeting of Shareholders of GATX Corporation (the “Company”) will be held at the Northern Trust Company, 50 South LaSalle Street, Sixth Floor, Assembly Room, Chicago, Illinois 60675 on Monday, April 30, 2018 at 12:00 p.m. Central Time. The record date for determining shareholders entitled to vote at the meeting was March 5, 2018.

The proxy materials for the 2018 Annual Meeting were sent to shareholders beginning on March 19, 2018.

**II. Rules of Conduct**

In order to provide a meeting that is informative and fair to all shareholders in attendance, the Company has established the following rules and regulations:

1. All shareholders and proxy holders must register at the reception desk before entering the room for the meeting.
2. The taking of photographs and use of audio or video recording equipment is prohibited.
3. The meeting will follow the Agenda announced by the Chairman or other presiding officer (“Presiding Officer”). Only those items of business of which the Company’s Corporate Secretary has received proper notice will be acted on.
4. All questions and comments should be directed to the Presiding Officer of the meeting. You may address the meeting only after you have been recognized.
5. If you wish to address the meeting, please raise your hand and wait for the microphone. Upon being recognized, please state your name clearly, your status as a shareholder or a proxy holder and present your question or comment. In order to speak at the meeting, you must be either a shareholder of record as of March 5, 2018, or be named in a proxy given by such a shareholder, and register at the reception desk prior to the meeting.
6. Each speaker must limit his or her remarks so that others may have an opportunity to be heard. The Presiding Officer reserves the right to limit the time allowed for each speaker’s remarks.
7. Please permit each speaker the courtesy of concluding his or her remarks without interruption.

8. The views and comments of all shareholders are welcome. The Presiding Officer has the authority to maintain the decorum of the meeting as necessary and the purpose of the meeting will be observed. The Presiding Officer or the Secretary will interrupt and terminate discussions that are: irrelevant to the business of the Company or the conduct of its operations; inappropriate to a shareholders' meeting; substantially repetitious of statements made by other shareholders; or discussions related to personal grievances.
