UPS receives President's Circle Award



Big Brothers Big Sisters of America (BBBSA) presented UPS with a 1998 President's Circle Award. BBBSA received a \$400,000 grant from The UPS Foundation as part of the Foundation's Volunteer Impact Initiative. BBBSA — which will use the funds to develop a

prototype school-based mentoring program — saluted UPS for celebrating the value of volunteers.

UPS is "Most Admired" on FORTUNE list

FORTUNE magazine named UPS "America's Most Admired Transportation Company" in the Mail, Package & Freight category for the 15th consecutive year in its annual listing of "America's Most Admired Companies." FORTUNE also ranked UPS, for the first time, as "World's Most Admired Package Delivery Company," resulting from a survey that asked executives and analysts to rank industry leaders in such traits as innovation, quality of management, employee talent, global effectiveness, and quality of products.

UPS recognized for NAACP involvement



The National Association for the Advancement of Colored People (NAACP) awarded UPS first place in the 1998 Exhibitors' Award category at the organization's July conference. UPS sponsors, and is involved in, other civic organization national conferences as well, including The National Council of LaRaza, the National Urban League, and the Organization of Chinese Americans.

Web site rated among world's best

A Global Internet 100 Survey, sponsored by *The Economist* magazine and Novell, ranked UPS's Web site first in the transportation category and 17th in the world. The site was described in survey responses as clever, quick-loading, and graphically appealing. The parcel tracking facility was also conveyed as a real tool.

Commitment to minority business development acknowledged



The Georgia Minority Supplier Development Council (GMSDC) granted its highest tribute to UPS, naming it "1997 Corporation of the Year." This award honors a company that shows unfailing commitment to supplier diversity development through purchases, technical and managerial assistance, and sponsorship of minority firms and programs.

UPS inducted into Urban League Hall of Fame

UPS was one of 35 companies inducted into the National Urban League Hall of Fame, which honors those companies that have contributed considerable time and effort to help the League work toward fostering equal opportunity. Award recipients display the leadership that results in notable contributions to the equal rights cause. 

16.4 million shares purchased in 1998

Employees purchased more than 16.4 million shares of UPS stock in 1998, an increase of 11.7 million shares over 1997. In addition, union-free employees also participating in the UPS Savings*PLUS* Plan received a stock match, in 1998, of nearly 1 million shares.

Of the 16.4 million shares, 1.1 million shares were purchased through our payroll deduction plan, and the remaining 15.3 million shares were purchased directly by our employees. The number of employee shareowners increased by 2,846 to 91,435.

In January 1999, First Union introduced additional features to its Voice Response Unit (VRU), allowing shareholders to access information in their personal accounts by entering their account number and a personal identification number (PIN).
