## HTC June 2008 Sales Report

Taoyuan, Taiwan, R.O.C. July 7, 2008 – HTC Corporation (TAIEX: 2498) today announced its total revenues for June 2008 were NT\$ 11,836 million, up 21.05 % YoY. For the second quarter of 2008, total revenues reached NT\$ 34,620 million with 28.89% year-on-year growth.

For the second quarter of 2008, pre-bonus adjustment self-assessed total net income before tax NT\$ 8,859 million, total net income after tax NT\$ 7,601 million, and self-assessed earnings per share after tax were NT\$ 13.26 based on the 573,134 thousand outstanding shares before ex-rights. Post-bonus adjustment self-assessed total net income before tax NT\$ 7,500 million, total net income after tax NT\$ 6,435 million, and self-assessed earnings per share after tax were NT\$ 11.23. Pre-bonus adjustment self-assessed earnings per share after tax were NT\$ 10.06, and post-bonus adjustment self-assessed earnings per share after tax were NT\$ 8.52 based on the current 755,394 thousand outstanding shares after ex-rights.
