HTC announced its self-assessed for December 2008 EPS After Tax reached NT\$38.03

Taoyuan, Taiwan, R.O.C. January 6, 2009 – HTC Corporation (TAIEX: 2498) today announced that revenues for December 2008 totaled NT\$ 13,579 million. The company also announced its self-assessed financial results for fiscal year 2008, ended December 31. Total revenues of the fiscal year 2008 reached NT\$ 152,559 million with 28.65% year-on-year growth. Pre-bonus adjustment self-assessed total net incomes before tax were NT\$ 37,778 million, self-assessed net incomes after tax were NT\$ 34,201 million, self-assessed EPS after tax was NT\$ 45.35 based on the current 754,148 thousand outstanding shares after share repurchase. Post-bonus adjustment self-assessed total net incomes before tax were NT\$ 31,657 million, self-assessed net incomes after tax were NT\$ 28,681 million, self-assessed EPS after tax was NT\$ 38.03.

For the fourth quarter of 2008, total revenues reached NT\$ 47,377 million with 21.45% year-on-year growth. Pre-bonus adjustment self-assessed total net income before tax NT\$ 10,762 million, total net income after tax NT\$ 9,810 million, and self-assessed earnings per share after tax were NT\$ 13.01 based on the current 754,148 thousand outstanding shares after share repurchase. Post-bonus adjustment self-assessed total net income before tax NT\$ 9,005 million, total net income after tax NT\$ 8,136 million, and self-assessed earnings per share after tax were NT\$ 10.79.
