HTC announced unaudited revenues for December 2010 and 2010 financial results EPS After Tax reached NT\$48.24

Taoyuan, Taiwan, R.O.C. January 6, 2011 – HTC Corporation (TAIEX: 2498) today announced that unaudited consolidated revenues for December 2010 totaled NT\$ 33,087 million. The company also announced unaudited financial results for fiscal year 2010 ended December 31. Total consolidated revenues of fiscal year 2010 reached NT\$ 278,761 million, up 92.92 % year-on-year. Unaudited consolidated operating income was NT\$ 44,185 million, consolidated net income before tax was NT\$ 44,696 million, total net income after tax was NT\$ 39,330 million, and unaudited earnings per share after tax were NT\$ 48.24 based on 815,239 thousand weighted average number of shares.

For the fourth quarter of 2010, total consolidated revenues reached NT\$ 104,005 million, up 153.26% year-on-year. Unaudited consolidated operating income was NT\$ 16,767 million, consolidated net income before tax was NT\$ 16,517 million, total net income after tax was NT\$ 14,593 million, and unaudited earnings per share after tax were NT\$ 18.01 based on 810,327 thousand weighted average number of shares.
