## HTC June 2009 Sales Report

Taoyuan, Taiwan, R.O.C. July 6, 2009 – HTC Corporation (TAIEX: 2498) today announced its total revenues for June 2009 were NT\$ 14,314 million, up 20.94% YoY. For the second quarter of 2009, total revenues reached NT\$ 38,202 million with 10.34% year-on-year growth.

For the second quarter of 2009, self-assessed total operating income NT\$ 6,891 million, total net income before tax NT\$ 7,100 million, total net income after tax NT\$ 6,490 million, and self-assessed earnings per share after tax were NT\$ 8.71 based on the 745,394 thousand outstanding shares before ex-rights. Self-assessed earnings per share after tax were NT\$ 8.15 based on the current 796,021 thousand outstanding shares after ex-rights.
