HTC announced its self-assessed for December 2009

EPS After Tax reached NT\$28.77

Taoyuan, Taiwan, R.O.C. January 6, 2010 – HTC Corporation (TAIEX: 2498) today announced that revenues for December 2009 totaled NT\$ 14,069 million. The company also announced its self-assessed financial results for fiscal year 2009, ended December 31. Total revenues of the fiscal year 2009 reached NT\$ 144,881 million with 5.03% year-on-year decline. Self-assessed total operating income NT\$ 24,234 million, total net incomes before tax were NT\$ 25,259 million, total net incomes after tax were NT\$ 22,654 million, and self-assessed earnings per share after tax were NT\$ 28.77 based on the 787,367 thousand weighted average number of shares.

For the fourth quarter of 2009, total revenues reached NT\$ 41,082 million with 13.29% year-on-year decline. Self-assessed total operating income NT\$ 6,177 million, total net income before tax NT\$ 6,307 million, total net income after tax NT\$ 5,579 million, and self-assessed earnings per share after tax were NT\$ 7.07 based on the 788,940 thousand weighted average number of shares.
