Mr Kuok Khoon Ho is currently a Director of Shangri-La Hotels (Malaysia) Berhad, which is listed on the Bursa Malaysia Securities Berhad and is familiar with the roles and responsibilities as a director of a public listed company.

He was appointed the Managing Director of Shangri-La Asia Limited in September 1997 and assumed the position of Deputy Chairman in October 2000, a position he held until August 2002. Shangri-La Asia Limited has its primary listing on The Stock Exchange of Hong Kong Limited and a secondary listing on the Singapore Exchange Securities Trading Limited.
