8. Review of Group Performance

Overview

The Group reported declines in net profit of 27.9% to US\$318.6 million for the quarter and 29.7% to US\$1.3 billion for the financial year on the back of poorer performance in Oilseeds and Grains while volumes across all business segments grew at healthy rates.

4Q2010 and FY2010 benefitted significantly from biological assets revaluation gains of US\$251.0 million while FY2009 was boosted by a net exceptional gain of US\$167.0 million from the sale of new shares in Wilmar China Limited. Excluding these items as well as the gain or loss from embedded derivatives in convertible bonds, the Group would have recorded net profit of US\$131.1 million for 4Q2010 (4Q2009: US\$411.2 million) and US\$1,162.9 million for FY2010 (FY2009: US\$1,604.3 million).

The weaker overall margins from a challenging operating environment resulted in the weaker performance. On segmental performance, Oilseeds and Grains was the primary contributor to the Group's earnings decline. While the other segments reported declines in margins, their performance was satisfactory under a challenging environment and when compared to the exceptional margins enjoyed in FY2009, particularly in the post-global financial crisis period.

Nonetheless, the Group continued to register healthy growth in sales volume for the quarter and financial year in every segment on rising demand for agricultural commodities especially in Asia, supported by its extensive manufacturing and distribution network.

Revenue

Revenue was up 31.4% to US\$9.1 billion for the quarter and 27.2% to US\$30.4 billion for the full year from increased sales volume and higher prices of agricultural commodities. All business segments recorded stronger volumes for both 4Q2010 and FY2010.

Cost of Sales and Gross Profit Margin

Resulting from higher sales volume and increased prices of agricultural commodities, cost of sales grew by 38.8% to US\$8.5 billion for 4Q2010, and 33.5% to US\$27.9 billion for FY2010.

For sales under CIF or C&F terms, the corresponding freight and insurance costs are recorded under selling and distribution costs or cost of goods sold. Export duty payable to the Indonesian Government is also recorded under selling and distribution costs. After aligning these cost items, the adjusted gross profit margin dropped to 3.2% for 4Q2010 (4Q2009 : 8.9%) and 6.0% for FY2010 (FY2009 : 10.5%).

The decline in margins was primarily attributable to the weak performance of Oilseeds and Grains and lower margins for Consumer Products for the quarter and financial year, as well as lower margins for Palm and Laurics for the year.

Net Gains From Changes In The Fair Value Of Biological Assets

The revaluation of biological assets to reflect mainly higher prices of palm oil resulted in a gain of US\$251.0 million for the quarter and financial year.

Interest Income

Higher average cash and bank balances for the quarter and full year contributed to a growth of 25.7% in interest income to US\$35.9 million for 4Q2010 and 38.8% to US\$135.4 million for FY2010.

Other Operating Income

The increase in other operating income by 184.2% to US\$186.7 million for the quarter was primarily attributable to a foreign exchange gain from the depreciation of the US\$ against regional currencies, partially offset by the absence of a gain in the fair value of embedded derivatives in convertible bonds (4Q2009 : US\$18.0 million).

Despite a higher foreign exchange gain, other operating income was only 4.8% higher at US\$492.3 million for FY2010 due to a net decline in the following non-operating items :

- gain from the sale of new shares in Wilmar China Limited of US\$178.8 milion in FY2009;
- gain from changes in the fair value of embedded derivatives in convertible bonds amounting to US\$98.0 million in FY2009; and

partially offset by an increase in income from other investments to US\$143.9 million FY2010 (FY2009 : US\$85.1 million);

Selling and Distribution Expenses

Selling and distribution expenses for 4Q2010 which amounted to US\$387.1 million were 77.5% higher than the same period last year. During the quarter, there was an increase in export duty and advertising and promotional expenses while freight and transportation costs were lower.

Export duties in Indonesia rose along with increased prices of palm products, which attracted higher rates. For example, export duty for crude palm oil ("CPO") averaged 10.8% per month in 4Q2010 (4Q2009: nil). However, freight and transportation costs dropped in line with higher usage of inhouse shipping services despite an increase in sales volume and average liquid bulk freight rates during the period.

For FY2010, selling and distribution expenses were up 36.2% to US\$1.1 billion on the back of higher export duty, whereby Indonesian export duty averaged 5.7% per month in FY2010 (FY2009: 0.5%). For both 4Q2010 and FY2010, the Group recorded higher advertising and promotional expenses due to increased promotional activities for new as well as high-end consumer products.

Administrative Expenses

Administrative expenses increased by 9.0% to US\$90.5 million for the quarter owing to higher bank charges from increased trade financing to finance higher working capital requirements. For the full year, administrative expenses were 19.1% higher at US\$341.6 million. In addition to increased bank charges, higher personnel and related costs also contributed to the growth. Reflecting the Group's expanded operation, headcount numbered 86,397 at December 2010 (excluding Sucrogen, as the acquisition was only completed towards end-December), an increase of 7.9% over 80,086 at 31 December 2009.

Other Operating Expenses

Other operating expenses include items such as share option expenses, loss in the fair value of derivatives embedded in convertible bonds, goodwill write-off and loss on the disposal of investments, among others. The increase in other operating expenses to US\$95.3 million for FY2010 was largely due to a loss in the fair value of embedded derivatives in convertible bonds.

Finance Costs

During the quarter, finance costs grew by 153.7% to US\$70.1 million, reflecting a 65.6% increase in average borrowings and an increase in effective borrowing rate. The 47.9% increase in finance costs for FY2010 was attributed to an 81.7% increase in average borrowings, of which a significant proportion was drawn down in 4Q2010.

Share of Results of Associates

Losses generated by the Group's associates in China contributed to the U\$\$21.1 million loss for the share of results of associates in 4Q2010. These losses also resulted in a 17.5% decline in the share of results of associates to U\$\$38.1 million for FY2010. The losses were partially offset by improved performance of associates in Ukraine, Malaysia and Indonesia.

Profit before tax

Profit before tax dropped by 17.1% to US\$428.8 million in 4Q2010 and 28.3% to US\$1.6 billion in FY2010. Profit before tax included the following non-operating items :

- gains from biological assets of US\$251.0 million (4Q2009 & FY2009 : US\$17.0 million),
- net exceptional gain of US\$167.0 million from the sale of new shares in Wilmar China Limited in FY2009, and
- gain or loss from embedded derivatives in convertible bonds (4Q2010 : U\$\$0.7m loss, 4Q2009 : U\$\$18.0 million gain; FY2010 : U\$\$27.2 million loss, FY2009 : U\$\$98.0 million gain).

Excluding the above items, the Group would have recorded profit before tax of US\$178.5 million for 4Q2010 (4Q2009 : US\$482.0 million) and US\$1,420.3 million for FY2010 (FY2009 : US\$2,012.4 million).

The poorer performance was the result of weaker margins across major business segments, especially for Oilseeds and Grains. In addition, a higher base was generated in the first half of last year following exceptional margins after the global financial crisis.

Income tax expense

Income tax expense dropped along with lower profits for 4Q2010 and FY2010. Effective tax rate for 4Q2010 was 10.8%, a small increase over 10.5% in 4Q2009.

For FY2010, effective tax rate was lower at 11.8%, compared to 15.6% in FY2009. This was partly attributed to a writeback in prior years' overprovision following finalisation of tax position with the local tax authorities. Excluding the tax writeback, the Group would have recorded an effective tax rate of 13.8% for FY2010.

Note: The effective tax rate for 2009 excludes exceptional gain from the sale of new shares in Wilmar China Limited and expenses related to its potential listing from the profit base.

Merchandising and Processing - Palm and Laurics

Revenue rose by 45.2% to US\$5.2 billion for 4Q2010 and 33.2% to US\$16.8 billion for FY2010 on the back of higher average selling price and sales volume over last year. Sales volume was up 9.4% to 5.8 million MT for the quarter and 9.2% to 20.8 million MT for the full year, from consumption growth as well as the Group's widespread distribution network and expanded capacities in Indonesia and Europe.

Despite the continued challenging operating environment in 4Q2010 which pressured margins, the Group recorded a respectable level of margins owing to the timely purchases of raw materials and sales of products. In addition, the Group's strong presence across the palm value chain, covering high value-added products like oleochemicals, specialty fats and biodiesel has also contributed positively. Profit before tax for 4Q2010 grew by 7.8% to US\$159.1 million. While profit before tax for FY2010 declined by 15.3% to US\$587.1 million, the group's performance was achieved under a difficult environment of tight CPO supply and the uncompetitive pricing of palm oil relative to other edible oils.

Merchandising and Processing - Oilseeds and Grains

Revenue increased by 15.9% to US\$3.0 billion for 4Q2010 primarily from higher prices while volume was 4.2% higher at 4.7 million MT. For FY2010, revenue grew by 24.7% to US\$10.2 billion, mainly from a 17.1% increase in volume to 18.3 million MT. The growth in volume for FY2010 was achieved through the Group's expanded capacities in oilseeds crushing, flour milling and rice milling, and China's rising consumption.

The segment recorded a loss before tax of US\$173.2 million in 4Q2010, reflecting very poor crush margins from excessive imports of beans by the industry and the Group's less timely purchases of raw materials. The weaker quarter further contributed to an 80.6% decline in profit before tax to US\$117.5 million for FY2010.

Consumer Products

The Group registered revenue growth of 29.3% to US\$1.4 billion for 4Q2010 and 20.5% to US\$4.7 billion for FY2010. Apart from higher average selling price, the growth was achieved through sales volume increases of 13.9% to 1.0 million MT for 4Q2010 and 15.3% to 3.7 million MT for FY2010. The growth in volume was driven by consumption growth and the sale of new consumer products in China, coupled with a strong market share build-up in Indonesia and Vietnam.

Margins declined in 4Q2010 attributable to the rising prices of edible oils feedstock during the quarter as well as a price increase restriction subsequent to an increase in selling prices in mid-October 2010. As a result, profit before tax for 4Q2010 declined by 33.4% to US\$37.5 million.

Profit before tax for FY2010 also showed a decline of 33.5% to US\$149.8 million as margins weakened from the exceptional levels achieved in the first half of last year, which benefited from low feedstock prices during the global financial crisis. The rising prices of feedstock since mid-FY2010 has further contributed to the weaker performance.

Plantations and Palm Oil Mills

Revenue was up 52.5% to US\$497.4 million for the quarter and 32.7% to US\$1.5 bilion for the year, reflecting higher sales volume and CPO prices.

Excluding the fair value gains from biological assets of US\$251.0 million (4Q2009 : US\$17.0 million), profit before tax of US\$129.6 million was an increase of 23.2% over the same quarter last year from higher realised prices. Although 4Q2009 had the benefit of forward sales at above market prices then, the Group managed to realise better prices for its own fruits in 4Q2010 in view of the run-up in CPO prices during the quarter. This was however, partially offset by higher unit production cost which resulted from a decline in production yield.

Despite a strong recovery in the market price of CPO during the year, profit before tax (excluding fair value gain from biological assets) for FY2010 of US\$384.8 million was only marginally higher than FY2009 as realised prices in FY2009 benefited significantly from forward sales at levels prior to the end-2008 financial crisis. Similar to 4Q2010, unit production cost for FY2010 was higher, largely from a drop in production yield.

The Group's production of fresh fruit bunches ("FFB") was up only 1.9% to 967,140 MT in 4Q2010 while yield declined by 13.3% to 5.18 MT per hectare due largely to lower yield in the newly matured hectarage and low crop trend in Sabah, East Malaysia. In addition, the wet weather in most parts of Sumatera in the first half of the year contributed further to an 11.0% decline in yield to 17.94 MT per hectare in FY2010.

Others

Revenue grew by 25.6% to US\$555.8 million for the quarter and 40.7% to US\$2.0 billion for the year, contributed primarily by increased shipping revenue. Apart from increased sales volume at the Group, higher usage of in-house services and improved freight rates resulted in the strong growth in shipping revenue.

Profit before tax almost tripled to US\$60.4 million for 4Q2010 on the back of stronger shipping profits and higher income from other investments. For FY2010, the 124.5% jump in profit before tax to US\$188.5 million resulted from higher shipping profits and the turnaround in the fertiliser business which generated losses in FY2009 from a difficult operating environment post-financial crisis.

Review of Balance Sheet and Cash Flows

Property, plant and equipment of US\$6.1 billion as at 31 December 2010 represented an increase of 55.9% over end-December 2009. During the year, the Group incurred capital expenditure of US\$897.7 million, mainly for plant expansion in Indonesia and China and the construction of new dry bulk vessels. The acquisition of new subsidiaries, namely Sucrogen, Natoleo and Jawamanis, contributed another US\$1.6 billion to the increase. The increase was offset by the regular depreciation charges and the disposal of five vessels.

Biological assets grew by 31.1% to US\$1.5 billion, attributable mainly to an increase in fair value of US\$251.0 million.

Inventories were up 71.0% to US\$6.7 billion due to higher prices of commodities and increased stockholding in response to rising prices and the Group's enlarged operations. Accordingly, average inventory turnover days increased to 70 days (31 December 2009 : 56 days)

Trade receivables grew by 57.1% to US\$3.1 billion as at 31 December 2010, due to the Group's revenue growth and higher prices of commodities. As the price increase was more pronounced in the fourth quarter of the year, it has also contributed largely to an increase in turnover days to 31 days from 25 days as at 31 December 2009 while the Group's credit policy has remained unchanged.

Other financial receivables increased substantially to US\$1.3 billion (current) and US\$106.8 million (non-current) from other short term deposits placed with financial institutions.

Other non-financial assets (current) doubled to US\$1.4 billion along with an increase in advances to suppliers. In view of rising international prices as opposed to lower domestic prices, the Group stepped up purchases of domestic oilseeds and grains, leading to an increase in advances to suppliers. There was also an increase in advances for the purchase of plant and equipment.

Trade payables grew by 76.5% to US\$1.4 billion as at 31 December 2010, on the back of higher prices of commodities, revenue growth and increased stockholding. Turnover days remained unchanged at 15 days.

Other non-financial liabilities (current) increased by 33.7% to US\$393.3 million due to an increase in advances from customers in China in line with higher prices as well as stronger year end orders in China in view of an earlier 2011 spring festival as compared to 2010.

During the year, the Group raised proceeds of US\$7.7 billion from loans and borrowings. The proceeds were utilised to fund a US\$2.3 billion outflow from operating activities resulting from higher working capital requirements, Other major application of funds included US\$1.5 billion for the acquisition of subsidiaries, US\$1.1 billion for capital expenditure, US\$1.8 billion deposits pledged for bank facilities, dividends payment and other short term deposits placed with financial institutions. As a result, loans and borrowings increased by 81.9% to US\$17.4 billion. Reflecting higher deposits pledged for the Group's increased loans and borrowings, other bank deposits and cash and bank balances were up by 32.2% from a year ago to US\$6.8 billion.

While net loans and borrowings (net of cash deposits and cash and bank balances) more than doubled to US\$10.6 billion, net gearing remained at a manageable level of 0.90x. (31 December 2009: 0.41x).

10. Prospects

Despite the weaker performance for the year, the Group is optimistic of its performance in 2011. Outlook of Asian economies, especially China, India and Indonesia remains positive and commodity prices are expected to remain firm. The Group will continue to leverage on its well-established presence in these markets and strong business model, coupled with its recent investments for growth. It will also continue to invest in existing and new businesses as part of its growth strategy.

Notwithstanding the pressure on margins for crushing and consumer products due to competition and high feedstock prices, together with Government restriction on price increase of consumer products, other segments of the Group are expected to perform well. Refining and oleochemicals should benefit from expanded capacities while plantations and fertilisers will benefit from higher palm oil prices.
