## Associates in Hong Kong can reach the Hotline by:

The Company's Hotline service provider has established a new collect number (770-776-5693) to be used by associates working in Hong Kong. The Company's Hotline can be used to anonymously report any issues or concerns.

#### **Instructions:**

- To place a call, first obtain a local operator and tell the operator you wish to place a collect call to the United States.
- The operator will then need to have the number supplied (770-776-5693).
- If the operator asks for a name the caller should state they are "United Stationers".
- The operator should connect the caller to the service provider's network where the initial greeting states (in English) "Operator, this line accepts collect calls, please accept this as verbal authorization".
- The caller will then be able to speak to an Interview Specialist.

## Associates in Mexico can reach the Hotline by:

- To place a call, dial the access code (01-800-288-2872) then wait for the prompt (or operator) to dial the number.
- Then dial the toll free number (877-767-6021) exactly as displayed (DO NOT DIAL a 1 at the beginning). If an operator comes on the line provide them the number to dial.
- This will connect the caller to The Network. The caller should hear a pre-recorded greeting, in their native language, indicating they have reached The Network. Unless the caller selects the English option when prompted on the prerecorded greeting, they will then hear music while the Interview Specialist is connecting the call with an interpreter. If the caller selects English, they will then be directed to an Interview Specialist.
