## **Point Blank Solutions, Inc. - Commitment to Your Privacy**

When you visit the Point Blank Solutions, Inc. ("PBSI") website or any of our other websites, we believe in protecting your privacy. We do not gather personal information about visitors without their knowledge and consent. We treat any personal information you give us with respect. We do not share your personal information with unrelated third parties for marketing purposes.

### **What personal information do we collect from you and how is it used?**

The majority of pages on our websites are delivered to you without requiring anything from you in return. Our websites are primarily for informational, not transactional, purposes. You may, however, choose to provide certain personal information through one of our websites, such as your name, email address, and billing information, when you register to create an account with us, or when you purchase items online. We will use the personal information you provide to fulfill your orders, provide customer support and provide you with information about our companies and products, per your request. If you subscribe to any of our newsletters or opt to receive alerts or information about our company, we will use the personal information you provide to fulfill your request. If you choose to no longer receive information from us, we will remove you from the distribution. You may also, at any time, request to have your personal information deleted from our database.

Our websites may contain links to other websites not owned by PBSI. PBSI is not responsible for the privacy practices or the content of other websites that are linked to our websites but are not owned by PBSI, including how personal information is collected and used.

### **Do we use "cookies"?**

Few pages on our websites issue "cookies" - small, unique files offered by servers to browsers that allow easier access the next time the same pages on a site are visited - and any issued are put to no further use. Furthermore, we do not reference cookies to any database, nor do we use them for any direct marketing purpose.

Additionally, your browser can usually be set to require your specific consent when any server wishes to present your computer with a cookie. It also usually lets you refuse cookies. Check your browser's preferences or options for details.

### **Are there any other situations where we collect personal information about you?**

A few of our pages are designed so that you visit them specifically to start an information exchange with us. Where appropriate, we will respond directly to you regarding these messages. The information collected from such pages will be used by PBSI only as represented to you.

### **Will your personal information be shared?**

Any personal information you provide on our websites is held or shared only by PBSI, its associate companies, or its representatives and agents, who are acting on our behalf with regards to your activity.

We do not sell, rent, or exchange mailing lists or responses of individual visitors to or with any unrelated third parties for marketing purposes. We respect the personal information you provide to us, and treat it carefully.

### **How is your personal information protected?**

Any personal information that we collect from any of our websites will be stored on secure data systems owned or managed by PBSI and safeguarded from improper use.

### **Sharing Your Information with Law Enforcement.**

We fully cooperate with reasonable requests for information from law enforcement agencies. As a result, we reserve the right to report to law enforcement agencies any activities that we reasonably believe to be unlawful, or that we reasonably believe may aid a law enforcement investigation into unlawful activity. In addition, we reserve the right to release your information to law enforcement agencies if we determine, in our sole judgment, that either you have violated our policies, or the release of your information may protect the rights, property or safety of PBSI, you, or one of our other customers.

### **Sharing Your Information as Permitted by Law.**

We may share your personal information with others as required by, or permitted by, law. This may include sharing your personal information with governmental entities, or third parties in response to subpoenas, court orders, other legal process, or as we believe is necessary to exercise our legal rights or defend against legal claims against us.

### **Transfers**

In the unlikely event that PBSI's assets are acquired, your personal information will be transferred to the acquiring company. In such a situation, you will be provided with notice of the transfer of your personal information and have the opportunity to opt-out of future uses of your personal information.

### **Changes to this policy**

PBSI reserves the right to make changes to this policy at any time without notice and in doing so will update this policy document online to reflect such changes. Should the privacy policy changes affect your personal information or how it's used, you will be notified via an email to the last email address you provided to us, and given an opportunity to remove your personal information from our database and opt out of receiving information from us.
