AIG PRIVATE CLIENT GROUP EXPANDS ITS MOBILE WILDFIRE PROTECTION

<u>UNIT[®] TO REACH MORE RISK-PRONE AREAS IN CALIFORNIA AND COLORADO</u>

Policyholder Demand Leads to Doubling of Mobile Truck Fleet

NEW YORK – June 18, 2008 - AIG Private Client Group, a division of the personal lines property and casualty insurance subsidiaries of American International Group, Inc. (AIG), today announced that its Wildfire Protection Unit[®] service has doubled the number of trucks in its fleet and expanded its reach to other communities within California and Colorado, as a result of policyholder demand.

The Wildfire Protection Unit, the first-ever mobile wildfire mitigation service, was created by AIG Private Client Group in 2005 as a proactive means to bolster the protection of policyholders' homes throughout wildfire season. The complimentary service is available exclusively to AIG Private Client Group policyholders who reside within designated response areas.

Through an exclusive partnership with Firebreak Spray Systems LLC, an industry leader in wildfire mitigation, the Wildfire Protection Unit reviews safety measures with policyholders and utilizes Phos-Chek®, the same environmentally friendly fire retardant used by the U.S. Forest Service. Phos-Chek is safe around plants, animals and people, and it does not stain or damage the home. Unlike gel-based retardants, which offer short-term protection, Phos-Chek can last an entire wildfire season or until washed off with a hose or heavy rainfall.

"Every homeowner should be adequately insured so, if disaster strikes, the cost to completely rebuild is covered," said Charles Williamson, President, AIG Private Client Group. "At AIG Private Client Group, we supplement our financial protection with loss prevention services like the Wildfire Protection Unit to help our clients avoid property damage from occurring in the first place."

The range of Wildfire Protection Unit services includes:

- **On-site consultation** Firebreak's wildfire protection specialists visit the policyholder's property in advance of wildfire season to assess its vulnerability.
- **Pre-treatment** If there is brush exposure, Phos-Chek is applied around the perimeter of the property. The retardant creates a "barrier" to shield the home.
- Emergency response A fleet of trucks equipped with Phos-Chek is on standby for policyholders 24 hours a day, 7 days a week. If a wildfire poses an immediate threat, the Firebreak teams are dispatched automatically to area homes. Access permitting, Phos-Chek will be applied to all combustible areas on the properties at risk.
