NEW YORK, November 3, 2008 -- AIG Environmental[®], a unit of AIG Commercial Insurance, announced that it is initiating electronic issuance of its insurance policies with AIG eDelivery[®].

AIG eDelivery is an Internet-based system that makes newly-issued insurance policies and endorsements from AIG Environmental available for download by brokers, expediting policy delivery and eliminating the need for traditional paper policy issuance. Policies and endorsements will be available to brokers online the next business day after issuance.
