DOVER CORPORATION DECLARES REGULAR QUARTERLY CASH DIVIDEND

New York, N.Y (May 5, 2005): The Board of Directors of Dover Corporation (DOV-NYSE) today declared a regular quarterly cash dividend of \$.16 (sixteen cents) per share, payable on June 15, 2005 to shareholders of record as of May 31, 2005.
