Zix Corporation Selected by Blue Cross Blue Shield of Arizona to Provide Secure e-Messaging to Meet HIPAA Requirements

ZixCorp Provides Leading Health Insurer with Secure e-Messaging across Arizona

DALLAS – August 15, 2002 – Zix Corporation (ZixCorp[™]), (Nasdaq: ZIXI), formerly ZixIt Corp., announced today that it has been selected by Blue Cross Blue Shield of Arizona (BCBSAZ), the state's largest health insurer, to enable secure e-messaging and meet stringent email security guidelines set by industry and federal mandates, including The Health Insurance Portability and Accountability Act of 1996 (HIPAA).

Using ZixVPM[™], ZixCorp's network-based secure e-messaging system, BCBSAZ will be able to quickly and cost-effectively communicate securely with subscribers, providers, and vendors. The ZixVPM system also helps BCBSAZ meet HIPAA privacy regulations and CMS (formerly known as the Health Care Financing Administration) security guidelines enforcing email security, privacy and message integrity that require yearly audits and self-assessments.

With ZixVPM, BCBSAZ continues to send and receive messages through their existing email client, but messages are now seamlessly encrypted by ZixVPM before being sent to recipients. ZixCorp's send-to-anyone solution allows all recipients to easily receive messages and respond to messages from BCBSAZ via encrypted email, without having to adopt any new technology or install any additional client software. To fully enable subscribers, providers, and other vendors who routinely communicate confidential data to BCBSAZ, the insurer has also secured licenses of ZixMail[™], ZixCorp's secure desktop email encryption solution, as part of BCBSAZ's deployment.

"It is very important that our e-messaging solution provide us the ability to safeguard Protected Healthcare Information (PHI) on both inbound and outbound communications throughout our business network. Deploying ZixCorp's fully integrated ZixVPM solution affords us this

In the enrollment, claims and medical review departments at BCBSAZ, employees will now be able to conduct business via secure email instead of faxes and phone calls, which are less secure, more expensive and time-consuming methods of communication.

It recognizes the importance of not only securing its own email communications through ZixVPM but also extending the solution to subscribers, providers, and vendors to provide them with full secure e-messaging capabilities through ZixMail," said Daniel S.
