The following announcement replaces Carnival Corporation & plc's 'Schedule 10, Notification Of Major Interests In Shares' issued incorrectly on February 16, 2004. In Schedule A of the previously issued release, Fidelity Investments (FMR Corp and Fidelity International Limited and their direct and indirect subsidiaries) level of holdings was listed incorrectly. Fidelity Investments purchased an additional 17,650 Carnival plc ordinary shares of US\$1.66 ('Shares'), increasing their non-beneficial holding in the Company to 7,608,759 Shares, and not 19,026,759 Shares, as previously reported. The total percentage holding of Shares following this notification is 3.60% of the Company's issued share capital, and not 9.01%. The entire corrected release follows:
